1. **CLASS TUITION** is paid by direct payment with a checking account or Debit/Credit card. **Direct Payments will be made September 2017- May 2018. First month's class fees, registration/recital fees and costume fees (where applicable) are due at time of registration.**
2. **COSTUME FEE** is due by October 1<sup>st</sup>. If you do not wish to auto debit costume fee, you will be responsible for half of the costume fee at time of registration.
3. **DANCE FEES** are due on the 1st of the month. **All accounts past due 15 days will incur a 5% late fee.**
4. **RETURN PAYMENTS** will be charged a \$20.00 fee.
5. **CREDIT CARD REQUIREMENT:** We require a credit card number to be on file for each student. Your credit card will be processed after the 10th of each month for any outstanding balance.
6. **WRITTEN NOTIFICATION (Email) is required for withdrawal** of a student at any time. You are obligated for payment until the date of notification.

When you enroll in the Direct Payment option, you are automatically signed up to have **Costume fees** and **Competition** fees deducted from your account. Music General will notify you of payment 7-10 days before processing.

If you are enrolled in Direct Payment, your **Costume fees are** deducted on **October 1<sup>st</sup>**. **Competition fee** (\$50.00) will be deducted on **December 1<sup>st</sup>**. However, if you choose to *opt out* of Competition, you will NOT be charged a competition fee.
